- JUROR:** Denis Ponsot has received awards from the Salmagundi Club, Sloggatt Juror's Award and several galleries throughout Long Island. Currently teaching at The School of Visual Arts, The JCC on the Upper West Side, Art League of Long Island, The Craft Students League and the Kids Club in Manhattan. Ponsot has been teaching watercolor painting, oils, mixed media and drawing for more than 25 years.
- AWARDS:** Those who receive **Best in Show** and **Honorable Mention** will participate in the "Masters Show" at the Main Street Petite Gallery in June 2012.
- ELIGIBILITY:** Open to all artists. Artwork must be available December 8 – January 30, 2012
- ENTRY FEE:** Artist members \$25.00 for two entries, non-members fee \$35.00, additional entries are \$5 each. Due to the limited wall space of our Main St. Petite Gallery there will be no more than 2 pieces of one artist's work selected.
- ENTRIES:** High resolution digital images formatted for **pc** (4 x 6 @ 300 dpi) or photos of artwork created within the past 4 years. (no artwork previously shown in the Main Street Petite Gallery will be accepted). Accompanying entry form must also be included.
- MEDIUM:** Any medium, including but not limited to acrylic, oil, watercolor, pastel, drawings, mixed media and collage. (no photography).
- SIZE:** Size limitation 36" in width and height including frame.
- CALENDAR:** All entries (CD or photo only) must be received by the Huntington Arts Council, 213 Main St., Huntington, by Friday November 4, 2011. Entries will not be returned.
- FINALISTS:** Artists will be notified of results by Friday, November 11<sup>th</sup> and if selected asked to drop off their work on Tuesday December 6<sup>th</sup> from 9am and 5pm.
- SALES:** The Huntington Arts Council will retain a 20% commission on all work sold.
- LIABILITY & INSURANCE:** All work is insured while in the possession of the Huntington Arts Council.
