- JUROR:** Tom Decker earned a bachelor of Fine Arts from Rochester Institute of Technology. He spent 20 years as a professional photographer in both New York City and on Long Island. Tom Decker Studio was founded in 2006 in Plainview, NY and has recently expanded his services to offer artists fast and accurate ways to get copies of their artwork.
- AWARDS:** The "Best in Show" and Honorable Mentions will participate in the "Masters Show" at the Main Street Petite Gallery in June 2011.
- ELIGIBILITY:** Open to all artists. Work must be available April 26 – June 10, 2011.
- ENTRY FEE:** Artist member \$25 for two entries. Non-members fee \$35 for two entries. Additional entries \$5 each.
- ENTRIES:** High resolution digital images formatted for **pc** (4 x 6 @ 300 dpi) or photos up to 2 pieces of work created within the past 4 years. (no previous images shown in the Main St. Petite Gallery will be accepted).
- MEDIUM/SIZE:** Photography only. Size limitation – 16" x 20" prints / 24" x 28" framed.
- CALENDAR:** All entries must be received at the Huntington Arts Council, 213 Main St., Huntington by Friday, April 1, 2011. Only digital images or prints accepted. Entries will not be returned.
- FINALISTS:** Artists will be notified of results by April 8, 2011. Delivery of originals is April 26, 2011 9am-5pm. Opening reception is Friday, April 29, 2011 6pm-8pm.
- SALES:** The Huntington Arts Council will retain a 20% commission on all work sold.
- LIABILITY & INSURANCE:** All work is insured while in the possession of the Huntington Arts Council.
