JUROR: Andrew Darlow is a NJ -bases photographer, writer and digital image consultant. His photography has been exhibited internationally and has been featured in numerous magazines and websites. He has lectured and conducted seminars and workshops around the world including Arles Photo Festival (France), School of Visual Arts, Columbia University and the International Center of Photography (ICP in New York)

ELIGIBILITY: Open to all artists including full time students.

MEDIUM: Photographs(digital, darkroom-produced or a combination of the two).

ENTRIES: All work must have been taken in the states of NY, NJ or Ct since 1/1/14. Photos must be original to entrant. No retouching apart from cropping, minor color balancing, dodging/ burning, minor saturation/contrast adjustment and selective or b/w toning for b/w photos. Must be two-dimensional and must be framed or presented as face-mounted acrylic print or stretched canvas/satin/etc. with a hanging wire on back. No artwork previously shown in the Main Street Gallery will be accepted. Submission materials cannot be returned.

SIZE: Up to 30"Hx30"Wx4"deep including frame.

ENTRY FEE: First 2 entries:

Artist members \$25, Full-time students \$25, Non-members \$35. Additional entries \$5 ea. No more than 2 works per artist will be selected

SALES: The Huntington Arts Council retains a 25% commission on all work sold.

LIABILITY & INSURANCE: All work is insured while in the possession of the Huntington Arts Council.
